The Department of Natural Resources (department) has reviewed for completeness the plan of operation modification for initial permitting of a CCR Landfill ("the plan"). The plan, submitted by Dairyland Power Cooperative, titled "Plan Modification for Initial Permitting of CCR Landfills, Alma Off-site Disposal Facility, Phase IV Landfill". The plan was dated and received by the department on January 30, 2023. The plan also includes an addendum titled "Plan Modification for Initial Permitting of CCR Landfills, Alma Off-site Disposal Facility, Phase IV Landfill – Addendum 1" dated and received by the department on January 17, 2024. The plan also includes an addendum titled "Plan of Operation Modification for Initial Permitting of Coal Combustion Residuals (CCR) Landfills – Addendum 2" dated and received by the department on July 24, 2024.

The department has determined the plan is complete in accordance with s. NR 514.045, Wis. Adm. Code.
